**\*Effective June 1, 2016** "Churches are required to pay a minimum Pulpit Supply of \$150 for one service or \$200 for two services. The minimum payment for Session Moderation shall be \$100. These fees include consideration for mileage driven, so additional mileage reimbursement shall not be required. Churches are further advised to request a W-9 from all teaching elders who provide at least \$600 worth of services in a single calendar year, and churches are required by the IRS to issue a 1099 for all individuals who receive at least \$600 in yearly compensation. Teaching elders should take note that their mileage to and from pulpit supply and moderator duties may be deducted from their taxes.
